to the Mammoth Jack, General Bob, for the fee of \$600 for a live foal, subject to the following conditions:

The full breeding fee is payable upon execution of this contract. Venmo is accepted, @ dora-psiakis, or with Paypal @ diamonddmules@gmail.com A convenient Pay Now button is on our website diamonddmules.com on the bottom right hand corner of Breeding page.

If mare does not settle and collection will be needed then that \$200 collection fee will be added upon mare pickup along with mare care costs, vet costs for ultrasounding, farm calls, etc., and any and all sedation costs needed to settle mare. DiaMond D Mule Farm's current breeding season for mares is March 1st to September 1st of 2024.

1. If a mare dies or is deemed unfit to breed during the breeding season, a substitute mare, approved by the jack owner, may be bred without any additional breeding fee, for breeding season 2024.
2. The mare owner agrees to have the mare checked by ultrasound no later than 18 days after insemination, by a licensed veterinarian. If ultrasound is unavailable, mare owner agrees to have the mare checked for pregnancy by licensed veterinarian within 30 days of insemination. Mare owner agrees to provide DiaMond D Mule Farm with the results of the pregnancy exam no later than 30 days after insemination.
3. Breeder agrees to diligently try to settle mare; however, if mare fails to settle, for any reason, Mare Owner will hold Breeder blameless. Mare Owner agrees to give Breeder ample opportunity to settle mare, including a minimum of 3 breeding cycles.

This Contract contains a **'Live Foal Guarantee'**. A live foal is described as a newborn foal that stands and nurses without assistance. If foal is born dead there are return privileges for the 2024 season only if Breeder is notified within 7 days and receives a veterinarian's statement confirming death. If after being pronounced "safe in foal", the mare should miscarry, abort or prove barren after leaving the Breeder's premises, Mare Owner has the privilege to return her for rebreeding during the current breeding season, or the following year, 2025.

A 'Breeding Certificate' will be issued for the foal conceived by this mating when jack fee, veterinarian expenses and all other expenses have been paid in full and, when mare has produced a live foal that stands and nurses by this mating. Both parties agree that DiaMond D Mule Farm, the Breeder, their agents or employees are not liable for death, sickness and/or accident including consequential damages caused to the mare and/or foal unless such death, sickness and/or accident was by the willful and wanton gross negligence of the Breeder; and the Mare Owner is not liable for death, sick-ness and/or accident including consequential damages caused to the stallion.

It is further agreed that should the Jack die, be sold by the owner, or become unfit for service, prior to settling the mare, that the breeding fee will be refunded, if it has been paid in full, thereby canceling this entire contract; or, if mare dies or becomes unfit to breed, the Breeder has the option to either (a) accept another mare according to paragraphs 4 and 5 as a replacement or (b) refund the breeding fee, if it has been paid in full, thereby canceling this Contract.

This Contract is non-assignable and non-transferable. The Mare Owner is responsible for all personal property taxes and full insurance on mare and foal (if desired)

Should either party breach this contract, the breaching party shall pay for the others court costs and attorney's fees relat-ed to such breach

This Contract represents the entire agreement between the parties. No other agreements or promises, verbal or implied are included unless specifically stated in this written Contract. Additional conditions should be individually initialed by each party. If none, check box. [].
